**Explanation of Responses:**

Baekgaard 2009 Grantor Retained Annuity Trust, of which he serves as co-trustee. Mr. Ray disclaims beneficial ownership of and pecuniary interest in all of these shares. Mr. Ray no longer has a reportable beneficial interest in 1,000 shares owned by his son and included in his prior ownership reports.
- These shares were sold pursuant to a written plan dated March 24, 2014 as specified in Rule 10b5-1 of the Securities Exchange Act of 1934, as amended.
- The prices reported in column 4 are weighted average prices. The shares sold on April 29, 2014 were sold in multiple transactions at prices ranging from \$28.52 to \$29.21, inclusive. The shares sold on April 30, 2014 were sold in multiple transactions at prices ranging from \$27.93 to \$28.78, inclusive.
